Fraud or Fairy Tales?

The CRCE held a meeting with the fascinating title of *Fraud or Fairy Tales: Russia and Ukraine's Electoral Experiences*, an analysis of the recent elections in Russia and Ukraine to a large and interested audience. Ljubo Sirc travelled to London to be with us, and took the Chair at the meeting. Earlier in the month Lisl Biggs-Davison and Helen Szamuely had attended a debate on much the same subject.

Publications

From Crisis to Growth: by Dr Vladimir Mau was published a few days before the meeting (see above). This is a major study on Russia's post-revolutionary economic policy.
