On 11th March, Raul Eamets from Tartu, Estonia, gave a talk on "How Flawed is the Estonian Economic Miracle?"

He is Professor of Macroeconomics at the University of Tartu, and Director of the Institute of Economics at the Faculty of Economics and Business Administration. Raul is also a long-term colleague of the CRCE and has contributed to the journal *Post-Communist Economies* and participated in the CRCE colloquium last year. His paper is published in *The Problems for Post-Communist Countries in the Context of the European Union*, CRCE 2007. Since 2004 he has served on the (Supervisory) Board of the Bank of Estonia.

Jože Dežman, Director of Museum of Contemporary History in Slovenia visited London in May to discuss his role as Chairman of the Committee for Hidden Graves Registration. Keith Miles, British-Slovene Association, and Lisl Biggs-Davison arranged a meeting at the House of Lords, thanks to Lord Pearson of Rannoch.
